Our recently updated website image is an important aspect of the EB-5 funding application package being directed by Dr. Joseph Penbera.

Spirit of California Entertainment Group's management continues to focus on the information required with Peter Alexander updating feasibility studies for phase 1. Phase I includes the Theme Park, Hotel and Convention Center.

The PenberaParis staff's work and the completion of the EB-5 application will provide funding for phase I of the continued development of the entertainment park venues as well as subsidiary company technologies.

Mr. Alexander and Dr. Penbera are fervent supporters of the Spirit of California Entertainment Park. They are excited for the recapturing of the California history and legacy in the multiple venues that will bring entertainment enjoyment to the public,

SOC Resource Management (SOCRM) continues its pursuit of advanced technology for utilizing unused resources.

Spirit of California in concert with SOCRM is pursuing resource recovery technology in its entertainment park project development and is partnered with AECOM Water Division in our endeavor.

We are working with a Central California agricultural region IWWTP for utilizing the industrial treated and stabilized organic residuals derived from its anaerobic directors

Our partnerships include an association with a state licensed compost facility specializing in agricultural services for the industrial residuals to be trucked to, stored and processed at their facilities. We will provide bulk distribution of the fertilizer product derived from the organic materials to the agricultural industry.

SOCRM technologies will bring many benefits to the city saving millions of dollars annually in various operations and locations. Future plans include the efficient re-utilization of CH4 / methane gases.

We continue to work with independent dairy owners to bring digester technologies to dairy farms improving the sites air quality with increased operational efficiency while producing energy and quality fertilizer by-products.
